2026 Sliding Scale Tuition Guide

Camp Flockworks is dedicated to making summer camp accessible to every Fort Bragg family while remaining financially sustainable. Our tiered pricing is based on the Federal Poverty Level (FPL), adjusted for Fort Bragg's cost of living. Full-price enrollments and donations help expand access for lower-income families — **no child is turned away for inability to pay.**

Tuition Tiers & Weekly Rates

Step 1 — Find Your Tier by Household Size & Annual Income

Household size includes all people living with the camper — parents/guardians, dependents, and the camper.

How Registration Works

Step 2 — Select Your Price at Registration

When you register, select the camp fee that corresponds to your income tier. Registration opens April 2nd. A deposit is required at registration, with the full balance due by May 15.

Step 3 — Income Verification (Tiers A–C Only)

Families in Tiers A, B, or C must submit their most recent tax return. We use **Line 11 (Adjusted Gross Income)** to determine your income tier. Tier D (full price) families do not need to submit documentation. If your family does not file income taxes, please reach out at director@flockworks.org and we'll work with you.

Step 4 — Limited Tier Availability

Sliding scale spots are first-come, first-served with limited availability in each tier. If a tier is full, you may register at a higher tier or join the waitlist.

Step 5 — Expanding Access

We monitor registration data and adjust tier availability based on demand and financial support. We also offer payment plans to help spread out the cost of tuition.
